More than 500 business, civic, and community leaders gathered at the Raymond F. Kravis Center for the Performing Arts on May 29 for The Chamber’s 2026 Business Awards, a celebration of the individuals, nonprofits, and companies driving innovation, leadership, and impact across Palm Beach County.

Among the morning’s highest honors was the Business of the Year Award, presented to Naztec International Group, LLC.
